### **Industry Intel:**

The latest round of Primary Care Appeals decisions published by NHS Resolution makes for disappointing reading. Several individual practice claims were reviewed—each one seeking retrospective payment related to influenza activity—and every appeal was declined.

The outcomes reaffirm a consistent position: historical CQRS flu claims cannot be recovered through the appeals process, it would seem regardless of the circumstances or evidence provided.

However, this does not mean all avenues for financial recovery are exhausted. Importantly, while historical CWRS (IOS) flu claims are not eligible, medicines-related claims can still be pursued. Many practices remain unaware of just how many medicines items may have been missed or incorrectly processed over the past six years—yet these claims are still recoverable.

If you are unsure whether your practice may have a valid medicines claim, the first step is simply understanding the scale of potential reimbursement. That is exactly what our Flu Calculator is designed to do.
