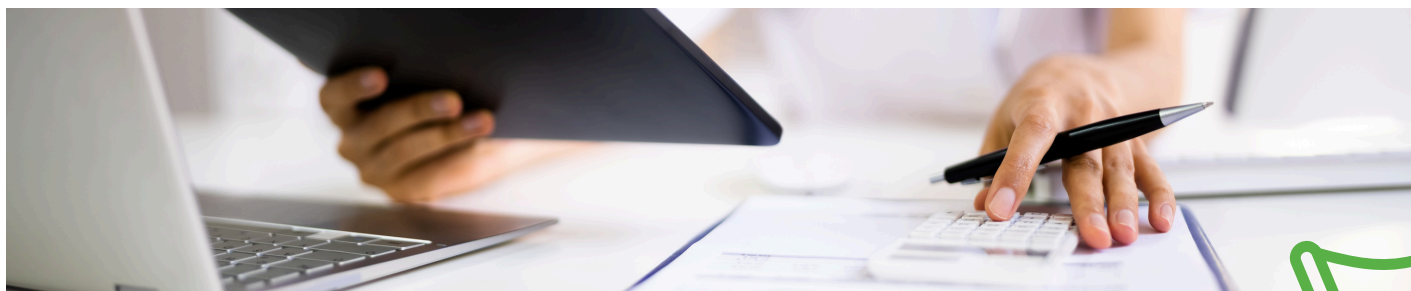

## Updates You Can't Miss

### Industry Intel:

As April Payroll approaches, accurately forecasting payroll costs is essential. Key statutory changes will significantly impact your practice budgets. Firstly, the National Minimum Wage (NMW) will rise from April, increasing staff costs across all relevant pay scales. Simultaneously, National Insurance (NI) thresholds will change, you will be paying an additional £612 per employee. Employer NI contributions are also set to increase, directly adding to employment overheads.

These cumulative adjustments will substantially alter your anticipated payroll expenditure. Importantly, no additional funding allocations have yet been announced to offset these rises, pending the Doctors' and Dentists' Review Body (DDRB) recommendations expected later this year. Enhanced Technology advises practices to carefully review and adjust payroll budgets immediately, ensuring financial stability through this transitional period. Accurate payroll forecasting now will help avoid unexpected shortfalls, securing your practice's sustainability until further funding clarity is provided.
